d) The TRUST shall invest in such manner as would comply with the various enactments governing investment of funds by educational institutions and charitable Trusts.

VIII.BOARD OF TRUSTEES:

- There shall benotless thantwo trustees and not more than seven Trustees in the Board of Trustees;
- 2. Only the following person could be elected asTrustees: a.The minimum ageof the Trustees shall be 18(Eighteen) years.
 - b)He should bea Person of sound mind.
 - c)He should not be an undischarged insolvent.
- The Board of Trustees so appointed by the Author shall hold such respective office for life, aftertheir death or resignation, their respective nominated legal heirs as may be decided by majoirty of the Trustees, as the casemaybe, hold such officefor his/their life and so on so forth. In the case of anyvacancy falling, owing to such nominated legal heir or such of the legal heir as decided by majority of the Trustees, to succeed the deceased Trustee, as the case may be, declining to accept the trusteeship, or otherwise, as the case maybe, in any of the Offices, the Managing Trustee for

- 4. Mr.D.Paranthaman Son of R.Dharma Naidu, aged about 45 years, residing at 24, Chengalvarayan Street, Shenoy Nagar, Madras-30, as the Joint-Secretary and Public Relations Officer of the Trust.
- 5. Mrs.J.Kasthuri, Wife of Mr.B.Jayachandran, aged about. Al. years, residing at 24, Chengalvarayan Street, Shenoy Nagar, Madras-30, asthe Su -Treasurer of the Trust.

IX.REMOVAL OF TRUSTEES:

The Trusteecan be removed from his office as Trustee if: a)He becomes aperson ofunsound mind.

b)He declaredasan insolvent andremains undischargedas such.

c) Ifheactsin such a manner that detrimental to the TRUST.

d)By resolution ofnotless than 2/3rdofthe Trustees.

f)Ifthe Trusteefailsto attend three consecutive meetings of the BoardofTrustees without leaveofabsence, from theManagingTrustee.In all the cases the ManagingTrusteeisthe sole authority to decide on thedesirability of such disqualification and his decision shall not be called into question.

X.REQUIREMENT TO HOLD AGENEERAL BODY MEETING:

- 1.The TRUST shall hold itsAnnual General Meeting within 18 months from the date ofdeclaration of the TRUST.Itmust be held in addition to any other General Meeting.
- 2.Subsequent Annual General Meeting must be held in each year within 6 months after the close of financial year but the interval between any two Annual General Meeting must not be more than 18months.
- 3.The Annual General meeting must be called on aworking day during business hours either atRegistered Office (or) atsome other place within the city in which the Registered Office is situated.
- 4.At least 21 days written notice is required to call on Annual General Meeting. Annual General Meeting maybe held with a shorter notice not less than 7daysif desiredby the Board of Trustees.
- 5.The Quorum for the General Body Meeting shallbe 1/3rd of the total number of Trusteesfor the time being on the date of notice to the meeting or 4 members physically present, whichever is less. It the Quorum isnot present, the meeting may be deferred by half an hour and reconvened. Quorumis not necessary for the adjourned meeting.

6.The Trustee can appoint proxies to represent himself in the Annual General Body and Extra-ordinary General Body

Meetings. Such proxies will have right of voting on are solution. But they shall not participate in any discussions in the meeting.

The following business shall be transacted in the general body meeting.

- 1.Adoption of accounts and auditor's report.
- 2. Appointment of auditors.
- 3. Any other businessthat the board of Trusteesdeemfit.
- 4. In all general meetings the managing Trustee shall be the chairman of the meeting. In his absence Vice-President shall be the chairman of the meeting. If both of them are not present the secretary shall act as the Chariman. If all of them are not present the General Body can elect the chairman. The chairman of the meeting shall have acasting votein the event of any tie on any cresolution.

XI.CALLING OF EXTRA-ORDINARY GENERAL MEETING:

Extra-ordinary general meeting of the TRUST can be heldin the following instances.

- 1.By resolution of the Board of Trustees
- 2.Upon request from at least1/3rdof the total number of Trustees as on the date of such requisition and the meetingshall be calleed within 30days of receipt of requisition.
- 3.The notice callingforthe extraordinary general body meeting shall specify the purpose for which the meeting wascalled for, the names and addresses of Trustee/Trustees at whose instance the meeting is called for besides the date and place of such meeting.
- 4.21 days notice shall be given in respectof such extraordinary general body meeting.
- 5. The Quorum for such extra-ordinary meeting shall be the same as that of geneeral body meeting. If no quorum is present at the appointed hour, the meeting shall be adjourned

byhalf an hour and reconvened. Quorum is not necessary for the adjourned meeting.

6.TheTrustee/member can appoint proxiesto represent himself in the Annual General Body and Extra-Ordinary General Body Meeting. Such proxies will havethe right of voting on aresolution.But they shall not participateinany discussions in the meeting.

XII.RIGHTS OF TRUSTEES.

- 1.Those persons who areadmitted asTrutee shall constitute the general body of the TRUST and shallhave the following rights and privileges.
- 2.The trustees shall be entitled attend and votein the Annual General Meeting of the TRUST for the election of Trusteeand for the passing of any resolution required to be pased by the General Body Meeting.
- 3.Each member is entitled to receive noticeof General Body Meetingof which he is a memberand to move any resolutions and to vote on any resolutions thereat.
- 4.The Trusteeship isnot transfeerable except by way of succession to the nominees as stipulatedabove.

XIII.PROCEEDINGS OF THE TRUST:

- 1. The Boardof Trustees shall meet at least once inSxi Months with a clear notice of seven days caused by the secretary or the Managing Trustee of the TRUST.
- 2.The Trustees may meet together forthe decidingon day today effective functioning of the TRUST and regulate their proceedings.
- 3. The ManagingTrustee of the Board shall preside over all the Meetings of the Board of Trustees during the term of his office. If any chance, he could not attend the meeting, the Trustees present shall electy one amongst them to preside over the meetings.

4. The resolution in writing signed by the majority of the Trustees by circulation shall be asvalid and effectual as if it had been passed at the meeting of the Trusteesduly called and constituted. Those matterswhich haveto be considered in the meeting as stated above would be considered by resolution circulation.

5. The decisions taken by the majoirty of the Trustees shall be valid and effectual and shall be carried out.

XIV.POWERS AND DUTIES OF THE MANAGING TRUSTEE:

1. The Managing Trustee shall have absolute, unfettered and full discretion in the matter of administration, maintenance and management of the TRUST and its properties now existing and/or acquired hereafter, and shall have the Power of day today management of the TRUST.

a) The Managing Trustee shall be empowered to: appoint any person for any office or job or Office of Agents, Legal Advisors, Accountants and others at such remuneration as the Managing Trusteemay deem fit.

b)appoint or form with such members as maybe decided by the Managing Trustee, admission committee for deciding on the manner of admission including qualifications required of students seeking addmissions to various courses offered bythe Insitution.

c)Advisory Committee for important matters as may be deem fit by the Managing Trustee from time to time.

The Managing Trutee shall be the chairman of all the committees.

2. To invest the TRUST funds in such securities and investments as may be decided by the Managing Trustee, in accordance with legal provisions as prevalent from time to time and as applicable to educational institutions and in particular in compliance with the provisions of the Income Tax Act.

- To buy or takeon leaseimmovable proper; Ities for the TRUST and or put up building or structures of land belonging to or under the control or possessio of the TRUST.
- 4. To sell or otherwise dispose of any immovable property.
- 5. To let any portion of immovable property forming part of the TRUST fund on such terms and conditions as he may think fit and further to accept surrender of any lease.
- 6. To open maintain, or operate bank accounts in name of the TRUST and to make the accounts operatable in such manner as he may decide from time to time.
- 7. To institute, conduct, defend compound or abandon any legal proceedings by or against the TRUST or Trustees, and allow time and includence for payment or satisfaction of any debt dues or any claim or demand by or against the TRUST. The TRUST shall be represented by the Managing Trustee or at the option of the Managing Trustee by any other Trustee, in all proceedings.
- 8. To delegateany power as he deems fit from time to time to any person and to execute such power of attorney as he may think fit for the purpose.
- 9.To withdraw any power or revoke any appointment of any employees or attorney, or person whosoeveer.
- 10. To borrow monies for the purposes of the TRUST on such terms and conditions asmay be decided from time to time and to authorise any one or more of the Trustees to execute such documents including the deeds of mortgage, charge, of hypothecation as may be necessary for the saidpurpose and also to create any mortgage or chargeon any of the TRUST properties movable or immovable for the said purpose.
- 11. To Amendany part of this Deed for the effective management of the trust.

XV. ACCOUNTS & AUDIT:

The TRUSTshall maintain regular accounts of all its transactions showing clearly the receipts and expenditure. All the expenses of the TRUST shall be properly vouched and audited by a Chartered Accountant every year. The Accounts of the TRUST shall be approved by the Boardof Trustees and General Body every year.

XVI.STATUTORY OBLIGATIONS:

a) The Trustees shall comply with all the relevant statutory obligations.

b) The TRUST shall invest the TRUST funds in such forms and in such securities as are permitted by the law governing investment of funds by Educational Institutions. No investment shall be made by the TRUST which shall render it ineligible for exemption under provisions of the Income Tax Act in respect of donations received by it or in respect of income earned by it.

XVII.INDEMNITY:

The Trustees shall at all times standindemnified in respect of any act they have made bonafide, committed or omitted to be done in respect of matters relating to the TRUST.

XVIIII.GENERAL:

1. The Author of the TRUST hereby declares that this declaration of TRUST shall bee irrevocable.

2. The income from the TRUST after meeting out the expenses shall always be used and applied for, for the furtherance of their objectives and purpose mentioned and specified herein above.

- 3. It SHALL be the endeavof of the TRUST that the benefits of the objectives of the TRUST shall be for the benefit of the public at large irrespective of sex, caste, creed, and religion.
- 4. Any change in the TRUST deed made on its future date, shall, be carried out only with the approval of the ManagingTrustee for the time being ofthe Trust. And it ishereby expressly declarred that no change oramendment made howsoever shall become effective unless the same isexpressly approved in writing by the Managing Trustee.



WHEREAS with the specific consent of all the Trustees of the Trust, the Managing Trustee for the time being of the Trust, had decided to pass and carry out the below described amendments to the Original Trust Deed, as amended by the subsequent Amendment Deeds, with effect from the date of execution of this Amendment Deed.

AND WHEREAS the below described amendments executed hereby shall be deemed to be integral part of the Original Trust Deed, as amended by the Subsequent Amendment Deeds and the recitals contained in this Amendment Deed shall prevail over all the contradicting clauses contained, if any in the Original Trust Deed as amended by the Subsequent Amendment Deeds.

Now this Deed of Amendment of Trust Deed of Dharma Naidu Educational & Charitable Trust witnesses as follows:

- 1. Consequent to the sudden demise of Shri.D.Sudharssanam, the Author of the Trust, his son Mr.S.Amarnaath, with the unanimous consent and approval of the Board of Trustees, has been elected as a Permanent and Life-Time Trustee to succeed Shri.D.Sudharssanam, the deceased Author of the Trust, as a Trustee on the Board of Trustees.
- 2. Shri.D.Duraisamy, has been unanimously elected as Chairman cum Managing Trustee of the Trust with immediate effect
- 3. The Part VII of the Original Trust deed, as amended by the subsequent amendment deeds, as may be applicable, titled "Management of the Trust" deleted and shall be replaced by the following, with effect from the date of execution of the Amendment Deed:

"VII. MANAGEMENT OF THE TRUST:

The TRUST shall be managed by Board of Trustees. The Managing Trustee of the TRUST has appointed the following Board of Trustees who have, at the request of the Managing Trustee of the TRUST, given their consent to be and act as Trustees of/under this Trust Deed:

- 1. Mr.D.Duraisamy , Son of R.Dharma Naidu, aged about 65 years, residing at 24, Chengalvarayan Street, Shenoy Nagar, Chennai-30, as the Chairman and Managing Trustee of the Trust.
- 2. Mr.D.Paranthaman, son of R.Dharma Naidu, aged about 63 years, residing at 24, Chengalvarayan Street, Shenoy Nagar, Chennai-30, as the Vice-Chairman of the Trust.
- 3. Mr.D.Dasarathan, Son of Mr.R.Dharma Naidu, aged about 61 years, residing at 24, Chengalvarayan Street, Shenoy Nagar, Chennai-30, as the Secretary of the Trust
- 4. Mr.S.Amarnaath, Son of Mr.D.Sudharssanam, aged about 40 years, residing at Old # 5, New # 11, First East Main Road, Shenoy Nagar, Chennai-30, as the Joint Secretary of the Trust.
- 5. Mr.S.Gopinath, Son of Mr.D.Sudharssanam, aged about 37 years, residing at Old 4 5, New # 11, First East Main Road, , Shenoy Nagar, Chennai-30, as the Joint Secretary of the Trust.

All trustees mentioned above shall be trustees for their respective life. After their death or resignation as the case may be, one of their respective nominated legal heir or in the absence of such nomination, the legal heir as may be decided by the majority of the Trustees for the time being of the Trust, shall succeed to the deceased or resigned trustee, as the case may be, and such succeeding person/trustee shall be the Trustee for his life and so on and so forth.

Elections shall be held once in every three years, to elect among themselves to various offices of the Board of Trustees and Trust. A Trustee so elected to an office shall hold such office for three years, for his life or resignation whichever occurs earlier.

Notwithstanding anything contained above, any vacancy caused, either by death or resignation, in any of the offices of the trust shall cause reconstitution of the Board of Trustees, after succession by the respective legal representative/heir of the deceased or resigned Trustee and further shall also cause election for various offices of the Trust though three year period since last election has not elapsed. The trustees (including the newly succeeding trustee) thus elected to various offices of the Trust, after such vacancy caused by death or resignation, shall hold their office for three years, from the date of such election. "

- 4. That the above-described amendments shall take immediate effect from the date of execution of this amendment deed.
- 5. That the clauses/recitals of the Original Trust Deed, as amended by the subsequent amendment deeds, wherever inconsistent or contrary to the recitals/clauses of this amendment deed, shall be deemed to have been amended in tune with the recitals/clauses of this amendment deed and the recitals/clauses of this amendment deed shall prevail over the clauses of the Original Trust Deed inconsistent with this amendment deed.
- 6. That this amendment deed shall be deemed and construed to be a part of the Original Trust Deed, and the recitals of this deed shall be deemed to be integral parts/recitals of the Original Trust Deed.
